## Boarding Agreement

In exchange for the exclusive use of communal pasture with shelter, and a stall if lessee is Partial or Full board with stall fees, the lessee agrees to the monthly boarding fee of \_\_\_\_\_, per horse. Partial board does not include feed or hay or maintenance.

The lessee shall have unlimited access to additional amenities only when those amenities are not reserved for special events or lessons. Amenities included are: horse playground (under construction), riding arena (under construction), round pen.

The lessee shall have the right at any time, in person or by authorized agent, to go upon Happy Horse Play Farm to inspect their horse to determine if said horse is being properly cared for and in good health.

Happy Horse Play Farm, LLC, reserves the right to terminate this agreement without refund in the event the lessee's horse is violent, either with other horses or people, or has significant stall vices that compromise the safety, comfort, and wellbeing of other horses in the barn, damages the facility or otherwise causes incident.

The lessee shall not hold Happy Horse Play Farm, LLC, any employees, volunteers, or owners liable for any serious injury or death of a horse arising from events not resulting from negligence on the part of Happy Horse Play Farm, LLC. Lessee shall hold the owners, employees and volunteers harmless for any injury to persons or damages to any property caused by the lessee's horse(s). Lessee will be held responsible for any and all damages to property, and equipment, belonging to Happy Horse Play Farm, LLC, caused by the lessee's negligence of equipment or property or by the lessee's horse(s).

This agreement may be terminated by either party with written notification.
